

VERIFICATION WORKSHEET 2025-2026

Your 2025-26 FAFSA was selected for review in a process called "verification." We are required to compare the information you provided on your FAFSA with the information provided on this worksheet and other required documents. If there are differences between your FAFSA and documents provided, Grand View University will make the necessary corrections. Please complete this worksheet as soon as possible and provide all information accurately and completely. **Missing or incomplete information may result in delays to receiving your financial aid and/or loss of funding for certain types of aid.**

WHAT YOU SHOULD DO:

- Be sure to fill out all sections of this worksheet completely, including all Parent sections if you are a dependent student.
- If you (and/or your parent(s) if you are a dependent student) filed a 2023 tax return with the IRS and did NOT use the Future Act Direct Data Exchange (FADDX) on your FAFSA, you will need to do one of the following two options:
 - Log into your FAFSA, select "Make FAFSA Corrections" and navigate to the Financial Information section. From there, follow the instructions to determine if you/your parent(s) are eligible to use the FADDX to transfer 2023 IRS information to your FAFSA (recommended).
 - If you are unable or choose not to use the FADDX for your FAFSA, you (and your parent(s) if you are dependent) are required to submit a signed copy of your 2023 Federal Tax Return to our office. If you are unable to provide a copy of your tax return, we can accept a Federal Tax Return Transcript. This form can be ordered at www.irs.gov or by calling 1-800-908-9946. You will need to provide your Social Security #, date of birth, and address on file with the IRS.
